

# Introduction

Last year, 2015, was another great year for the sport horse sector and one of the highlights was the launch, in March, of our 10-year strategy, *Reaching New Heights*. This important document was coordinated by Teagasc, the RDS and Horse Sport Ireland (HSI) and received input from a lot of people involved in the sector. The big challenge for the sector, going forward, is in ensuring that we can resource all the ambitious recommendations contained in *Reaching New Heights*, so that our sector can realise its full potential. The ground work has been laid but there is a lot still to do and all stakeholders need to work together if we are to succeed.

The enthusiasm of our young people will make our sector great and investing in them is one way to ensure that we have a sustainable sector. In addition to participation in the sporting disciplines, we need to get more young people involved in breeding and in the organisational infrastructure of HSI and the affiliates, as new, innovative ideas and approaches are needed. In addition, many of our activities depend on an army of volunteers to survive and succession planning is key to a great future.

We have the international marketing division out of the blocks and we plan to build on it over the coming years to make Ireland the 'go to place' for a horse or pony for all level of rider.

The inaugural Jumping in the City series, which endeavoured to attract new spectators to the sport of showjumping, ran on three Fridays in June 2015 in greyhound stadia in Limerick, Cork and Dublin. It was encouraging that the series was winner of the Best Innovation in Sport award at the Irish Sports Awards in early November. Spectators, media coverage and sponsors are inextricably linked and we need to continually look at our various sporting disciplines to make them more attractive to the masses.

Our international showjumping riders, with Bertram Allen in the vanguard, kept the tricolor flying in arenas all around the world throughout the year. And, they certainly didn't disappoint the home spectators when the team of Bertram Allen, Greg Broderick, Cian O'Connor and Darragh Kenny won the Aga Khan trophy at the Discover Ireland Dublin Horse Show.

One objective for the future has to be to connect our breeders with the market requirements and provide Irish horse power to the top riders in the various disciplines. The calibre of horses jumping in the Studbook Series and young horses classes around the country has to give us optimism for the future. Our eventers continue to hold their own at the top of the World Breeding Federation for Sport Horses (WBFSH) rankings and Irish-bred show horses are in the limelight in all the big shows in the UK. We have work to do to connect our breeders of young horses with the market place, as many are not getting adequate return for their endeavours. We are in global competition and we need to focus on quality and high standards at all levels if we are to compete with the other horse breeding nations.



Our pony riders and young riders were not to be outdone by their senior counterparts in 2015 and their ongoing successes have to give us great optimism for the future. I compliment our chefs d'équipe, coaches, all the support staff, the many owners and sponsors who pay the bills, and the parents, who play a huge role in enabling our talented young riders realise their full potential.

I acknowledge the hard work of all those in our equestrian centres and show venues. Their endeavours and investment in their facilities enable producers to bring on their young horses, and help riders to hone and develop their skills.

We are a broad church and it is amazing how a love for horses has brought so many people from different walks of life together for business, pleasure and friendship. In addition to the Fédération Equestre Internationale (FEI) disciplines, our affiliates cover disciplines such as polo, harness racing, hunting and mounted games. A passion for horses is in the DNA of many Irish people and despite a lack of monetary return, for a large proportion of us, the enthusiasm does not

We need political recognition and support, in both the north and the south, for a sector that contributes so much to communities throughout the length and breadth of the Island of Ireland, to give a helping hand to the many initiatives, that are ongoing and in the pipeline, for breeders, producers and competitors.

I acknowledge the hard work and commitment of the executive and staff of HSI and the contribution of my fellow board members and members of the sub-boards. I also thank the many committees that enable HSI to function, and the army of volunteers in the affiliates who keep our sector vibrant and growing. Cooperating and working together, we can achieve great things.

Chairman Horse Sport Ireland



In 2015, a roadmap for the industry entitled *Reaching New Heights* was published. This document was the product of more than 18 months' work from Teagasc, the RDS and Horse Sport Ireland (HSI). It was launched in March 2015 by then Minister for Agriculture, Food and the Marine, Simon Coveney. On foot of the report, an extra allocation was provided to HSI to establish an international marketing division. Subsequently, Elaine Hatton was appointed as director of International Marketing and this new division has now been set up.

The equine sector was also included in the new Knowledge Transfer Programme, which was rolled out by the Department of Agriculture, Food and the Marine during 2015. This model has been very successful in other sectors and it has the potential to be a game changer for the sport horse sector.

The extra funding allocation from the Department of Agriculture, Food and the Marine also allowed us to introduce the new performance foal championships in showjumping and eventing, as well as young mare championships in both disciplines.

The challenge is to continue to implement the recommendations in Reaching New Heights. However, it is clear that this will not be possible without the allocation of significant extra resources to the sector. Reaching New Heights will need a real commitment from the Government in the form of substantial extra funding.

Last year was another very successful year for Irish equestrian sport. Highlights included the showjumping team winning the Aga Khan in Dublin and the eventers having their first-ever win in a Fédération Equestre Internationale (FEI) Nations Cup, when they won the final Nations Cup event of the year at Boekelo.

One of the highlights of 2015 was the Jumping in the City series which was run by HSI, in conjunction with the Irish Greyhound Board and Showjumping Ireland. The fact that it secured the Best Innovation in Irish Sport award at the Irish Sport Awards was due recognition for all those involved.



Our showjumping team missed out on Olympic qualification in the European Championships at Aachen by less than one fault. At that event, Cian O'Connor and his horse, Good Luck, had their round interrupted by a ring steward. Unfortunately, Cian and Good Luck picked up four faults. The subsequent appeals all the way to the Court of Arbitration for Sport (CAS) proved to be costly and time consuming. The original concept of CAS, as a sport-specific dispute resolution mechanism to avoid costly court cases, is far removed from the reality. It is now a very expensive route to take. Of course, we could have decided not to appeal but when there is still a chance of getting a team to the Olympic Games, there is an expectation from riders, owners and other stakeholders that the National Federation will exhaust every possibility to secure a place.

Our underage teams continued their spectacular run of successes, while there were medals for our young showjumping and eventing horses at their respective World Championships. This augers very well, particularly in showjumping, as it provides demonstrable evidence that progress is being made with the breeding and production of Irish Sport Horses.

No horse ridden by an Irish rider in national or international competition, returned a positive test. However, this is an area we need to keep as a top priority. The integrity of the competitions in our sector underpins the entire industry and must always be a top priority.

I want to thank all HSI board members and volunteers for the commitment they have shown and continue to show to the organisation and the sector in 2015. As CEO, I want to say a special word of thanks to all HSI staff for their work in 2015, and for showing remarkable commitment and flexibility.





# Senior Showjumping: European Championships 2015

The European Showjumping Championships took place at Aachen (GER) in August 2015. The Championships were Ireland's last chance to qualify a team for the 2016 Olympic Games in Rio De Janeiro, Brazil.

The Investec Irish Showjumping Team, came within less than half a point of securing one of the three Olympic qualifying slots available at the final of the European Jumping Championships in Aachen, Germany. With five of the 10 teams that qualified for the final, from 22 starters chasing the three Rio slots, Ireland finished fourth in this category and took seventh spot in the overall European team ranking. Controversially, Ireland's third rider, Cian O'Connor, and his nine-year-old stallion, Good Luck, were on course to repeat their clear round from the previous day when a member of the Aachen arena staff inexplicably crossed their tracks on the approach to the final sequence of fences. O'Connor unexpectedly had the next fence down. Irish team officials lodged an appeal with the Aachen ground jury over the incident, and then with the appeals committee at Aachen, but without success.

Speaking after the competition Damian McDonald, Horse Sport Ireland (HSI) CEO, said: "We are very proud of the Irish team's performance at the European Championships

in Aachen. Regarding the incident where an arena official crossed the tracks of Cian O'Connor and his horse, Good Luck, causing interference, we will be examining all of our options provided for within the rules of the International Governing Body the Federation Equestre Internationale (FEI) including a potential appeal to the Court of Arbitration for Sport (CAS)."

In December 2015, the appeal by HSI and Cian O'Connor was heard by the CAS in Lausanne, Switzerland. Speaking prior to the hearing, HSI chairman, Pat Wall, said: "To have a showjumping team at the Olympic Games is very important for Ireland. Our riders and their owners are doing a huge amount to promote Ireland as a world leader in the sport of showjumping. They went to the European Championships to pursue their Olympic dream. A freak incident occurred on the day which hindered our efforts. All we are looking for is fair play. We are convinced that if this incident had not happened, the Irish showjumping team would be going to the Olympics." CAS advised HSI that the appeal had been rejected. Ireland's only chance of fielding a showjumping team at the 2016 Olympic Games is for another team to drop out. Ireland are however on course to qualifying for at least one, if not two, individual places at the Rio Games.

# Horse Sport Ireland Mare Selections

Mare selections for the Irish Sport Horse Studbook and Irish Draught Horse Studbook are carried out at regional venues annually in spring and autumn. Mares must be a minimum of three years of age to be presented for selection, although Irish Draught mares can be presented for selection at two years of age in autumn. Mares undergo a veterinary examination and are assessed on conformation and movement using linear profiling. Movement is assessed in-hand and loose in an arena. Owners can choose to have their mare's athleticism assessed through loose jumping for additional merits.

# **CapallOir**

Established in 2011, CapallOir is an online version of the Irish Horse Register, developed and maintained by Horse Sport Ireland (HSI). The database contains records for more than 420,000 horses, with pedigree dating back to before 1890.

A four-generation pedigree and progeny report can be displayed on screen with a facility to have either report emailed to the user as a PDF document. In cases where horses have competed under Fédération Equestre Internationale (FEI), British Eventing (BE), Showjumping Ireland (SJI), Eventing Ireland (EI), or Association of Irish Riding Clubs (AIRC) rules, there will be a link directly to that horse's results in the relevant database. Genetic diversity percentages are shown on CapallOir for Irish Draught stallions and mares in Ireland, Australia and Canada.

In 2015, CapallOir was accessed 3,969 times and had a total of 1,145 users. The total number of animals searched for on the database was 44,5096. The most searched for horse was the Irish sport horse stallion, Carrick Diamond Lad, followed by the legendary stallion, Cruising (ISH).

# FEI World Breeding Jumping Championships for Young Horses – Lanaken

The World Breeding Federation for Sport Horses (WBFSH) Fédération Equestre Internationale (FEI) World Breeding Jumping Championships for Young Horses, take place annually in September in Lanaken, Belgium, where the world's best five, six and seven-year-old showjumpers compete. All horses must be registered in a WBFSH member studbook and each country is given a quota for the number of horses they can select to compete per age category. The 15 Irish sport horses selected to compete in 2015 are shown on the


next page with their results.

# FEI World Breeding Eventing Championships for Young Horses – Le Lion d'Angers

The Fédération Equestre Internationale (FEI) World Breeding Eventing Championships for Young Horses take place annually at Le Lion d'Angers, France.

These championships consist of two competitions, a CCI 1\* for six-year-olds and a CCI 2\* for seven-year-olds. The World Breeding Federation for Sport Horses (WBFSH) competition forms part of this prestigious event, with the winning studbook awarded the World Breeding Trophy for Young Horses. In total,

104 horses are selected by their countries. In 2015, of the 104 horses selected to compete, 23 were Irish Sport Horses. Eight of these represented Ireland and 15 represented other countries including Australia, Finland, Great Britain, Italy and New Zealand. Ireland's Sophie Richards and SRS Adventure (ISH) won bronze medal in the six-year-old World Championship 2015, while the Irish Sport Horse Studbook took the Overall World Championship title.



#### Silver Spurs 2015

The Silver Spurs scheme, sponsored by Horse Sport Ireland (HSI) and organised by Dressage Ireland, aims to identify and develop talented young riders and encourage their progress by awarding training bursaries, giving direction and advice and providing a pathway for skills development in their chosen equestrian discipline. #### Discover Ireland Dublin Horse Show at the RDS

The Discover Ireland Dublin Horse Show is Ireland's biggest equestrian event and takes place at the RDS in August each year. The show is attended by approximately 100,000 visitors over its five-day duration and includes five-star international showjumping, the centrepiece of which is the Aga Khan Nations Cup. In addition, a huge amount of other international and national showjumping classes take place, as well as showing, eventing and pony classes. Horse Sport Ireland (HSI) supports the three-year-old loose jumping competition and the four-, five- and six-year-old national showjumping championship classes.

#### Tattersalls International Horse Trials, in association with Horse Sport Ireland

Tattersalls International Horse Trials, in association with HSI, are held annually at the Tattersalls sales complex in Ratoath, Co. Meath. Attended by more than 20,000 people, the event features a number of classes at international and national level, and attracts top riders from all over the world to compete. The Irish Sport Horse Studbook is the leading studbook for eventing horses in the world and the HSI Breeding Sub Board considers it strategically important for Ireland to have a flagship eventing competition in the country.

#### **Badminton International Horse Trials**

Badminton International Horse Trials is one of only six four-star events held in the world each year. Badminton takes place in May and is considered to be the world's premier three-day event. It attracts the elite of eventing competitors – both horses and riders. HSI supports Badminton in the form of promotion of the Irish Sport Horse Studbook – the world's leading studbook for eventing horses.

#### Irish Breeders Classic

The Irish Breeders Classic, which was initiated in 2012, is a showjumping competition for five- and six-year-old Irish-born horses with a total prize fund of €50,000, making this competition the one with the richest prize fund in the world for young horses. Five per cent of the overall prize fund goes directly to breeders, with breeders' prizes of €3,000 being provided by HSI. The prize fund is generated by voluntary contributions from organisations and individuals with the Irish sport horse industry, including HSI.

#### Connemara Pony Show

The Connemara Pony Breeders Society (CPBS) hosts the Connemara Pony Show, as part of the Connemara Pony Festival, in August each year at the showgrounds in Clifden, Co. Galway. HSI provides financial support to the show each year. The show includes loose jumping, in-hand classes, ridden classes and working hunter classes.

#### Irish Farriery Authority

The Irish Farriery Authority is the umbrella body for farriery in Ireland. It is responsible for providing farriery training in Ireland and maintaining a database of practising farriers. HSI provides annual funding towards the organisation's activities.



## Irish Sport Horse Studbook Showjumping Series 2015

The Irish Sport Horse (ISH) Studbook Showjumping Series celebrated its 10th year in existence in 2015. Eight legs were held between April and August. Weatherbys thoroughbred mares and stallions which had met the IHR inspection criteria were also eligible to compete, as well as any stallion which had commenced the HSI stallion inspection procedure and been awarded 'Preliminary Approved' classification.

## International Marketing



## **International Marketing Division**

In April 2015, Horse Sport Ireland (HSI) announced the appointment of Elaine Hatton as international marketing director, heading up the new International Marketing Division within HSI. The creation of this new department was recommended in the industry strategic plan, *Reaching New Heights*, and funded from an additional allocation made to HSI by the then Minister for Agriculture, Food and the Marine, Simon Coveney, in the 2015 Budget.

Speaking at the announcement, HSI chief executive, Damian McDonald, said: "There is a global market for horses and ponies for all levels of riders and we need to connect our breeders and producers with buyers in a range of markets. Elaine's experience in Irish thoroughbred marketing, which does outstanding work in marketing to the thoroughbred sector abroad, will be a huge asset as we start out on the journey of establishing an International Marketing Division for the sport horse sector. The Irish sport horse sector is worth over €700m to the Irish economy and we believe we can grow the sector further by driving export growth in the coming years."

The International Marketing Division, through the Irish Horse Gateway (IHG), promotes Irish horses and ponies, liaises with prospective international clients and oversees the Inward Buyer Programme. In addition, the division manages Team Ireland Equestrian sponsorship and promotional activities, as well as overseeing the press and public relations wing of HSI.



#### Irish Horse Gateway

Established in 2013 by HSI, the Irish Horse Gateway (IHG) was initiated to connect the world to the Irish horse. It is the first point of contact for overseas clients seeking information on Irish horses and ponies for equestrian sport and leisure. In 2015, under the banner of the IHG, the International Marketing Division of HSI had a presence at all domestic and select international sales auctions, to ensure that the IHG message is being communicated and international buyers

are aware of the services being offered. Feedback was sought about international buyers' experiences of purchasing animals at Irish sales. In addition to sales, the IHG also had a visible presence at international events held in Ireland in 2015. RDS Dublin Horse Show, Millstreet International, Camphire International, Ballindenisk International and Clifden Pony Show were some of the events that were sponsored by or attended in order to meet visiting international riders and owners.

## Record-breaking year for Goresbridge Go For Gold & Supreme Sale of Showjumpers


The Goresbridge Go For Gold and Supreme Sale of Showjumpers sales took place in November 2015. The latter sale saw the Irish sport horse, Dougie Douglas, set a new Irish record for public auction by selling for €1.4 million. The Nations Cup showjumper, competed by Holly Gillott and jointly owned by the rider and Graham Smith, has represented Great Britain in a number of Nations Cups. The 10-year-old chestnut gelding, by Ard VDL Douglas (KWPN) out of the High Roller (ISH) dam Neills Girl (ISH), was purchased by Irish agent, Barry O'Connor, for USA's Katie Dinan.

Alexander Butler and Neal Fearon's seven-year-old prospect, Dekato, was sold for €250,000 to Michael Drea of Great Britain as a mount for his daughter, showjumper Jessie Drea. The 11-year-old Irish sport horse, Javas Wild Child, was also purchased by Michael Drea for €80,000. The last lot of the auction was another first for Ireland, where an embryo out of the 2014 Goresbridge sales graduate, Ard Ginger Pop, was purchased for €50,000 by Barry O'Connor on behalf of a European client.

The 2015 Go For Gold sale recorded the highest-ever clearance rate recorded at Goresbridge public auction, with a rate in excess of 85 per cent clearance. The 10-year-old Irish sport horse mare, Gorsehill Pearl was purchased for €85,000 by Irish Olympian, Joseph Murphy. The Go For Gold sale

generated sales of over €1 million throughout the auction. The two sales auctions attracted buyers from the UK, America, Europe and beyond and highlighted the standard of sport horse production in Ireland. Combined, the sales generated approximately €3.2 million for Irish breeders and producers.

#### Advertising

The UK is and will continue to be a critical market for Irish horses and in 2015, an advertising deal was brokered with the UK's most popular equestrian magazine *Horse and Hound*. The advertising campaign was set up to advertise the IHG, Irish sales dates, and to publicise the success of Irish horses in international competition.

#### International sponsorship

In September 2015, HSI, under the IHG brand, was official partner at the Longines FEI European Eventing Championships, held at Blair Castle. The IHG sponsored the International Supporters Pavilion, had a dedicated televised fence on the cross-country course and a branded fence in the showjumping ring. An IHG trade stand was also in operation at the event to publicise the services on offer from the IHG and to promote the Irish Sport Horse Studbook as the world's leading studbook for eventing horses.

Staying in the UK but moving to the disciplines of showing and showjumping, the IHG was sponsor at the prestigious

Horse of the Year Show (HOYS) in Birmingham in October, 2015. This show attracts in excess of 60,000 visitors annually and more than 80 per cent of those are horse owners. Highlighting the favourable message of buying in euro to the English buyer was a key selling point at this show, in addition to increasing awareness of the IHG brand.

#### Trade missions

In November 2015, the IHG travelled to Asia to attend trade fairs in China and Korea. The China Horse Fair was the first stop on the tour, followed by a visit to Shanghai, where the Chongming East Beach Equestrian Centre was built in March 2016. Following on from this, the IHG was represented at the Korea Equine Industrial Association Symposium. Asia is a new emerging market in the field of equestrianism and it is hoped the IHG can be involved in supplying goods, services and livestock to this developing market.

#### **IHG Brand**

In 2015, there was a strong focus on the IHG brand and website services, aiming to connect both national and international buyers with registered horse breeders and producers. The IHG website attracted, on average, more than 8,000 users per month. Internationally, it was the most visited by users in the UK, followed by the US and then Sweden. There were 270 active sellers registered with the IHG.

## General Activities





The Horse Sport Ireland (HSI) Coaching Programme is designed to provide candidates with a pathway to a career as a successful competition coach. HSI coaching courses are delivered by professional equestrian tutors and use modern techniques to improve both horses' and riders' performance. Coaching courses are currently delivered across four levels and are accredited by Coaching Ireland, the Irish governing body for coaching in all sports.

The HSI coaching system is a competition-based coaching system and focuses solely on coaching. The courses offer a better understanding of modern competition requirements, coaching skills, technical knowledge and principles of good communications, so they are also suitable for parents, breeders, young horse producers, competitors, riding school instructors and anyone involved with, or with an interest in, horses and the industry.

Since the HSI Coaching Programme has been operational, it has delivered hundreds of courses all around Ireland and

further afield. The HSI Coaching System has been adopted by the British Equestrian Federation (BEF) and the Fédération Equestre Internationale (FEI). A very successful year for HSI Coaching 2015 saw more than 320 applicants taking part in coaching courses around the country.

#### HSI Cross-Country/Eventing Workshops

Five workshops (79 participants)

The Horse Sport Ireland (HSI) Level 1 Apprentice Coach course is a four-day course providing candidates with the skills and techniques to work as a coach to novice level. It is recommended that HSI Level 1 Apprentice Coaches work under the guidance and supervision of a higher qualified coach.

The HSI Level 2 Coach qualification is currently an eight-day course and provides candidates with the skills necessary to work competently as an independent coach up to elementary level. Candidates must attend all course contact time and achieve the required standard at an official assessment in dressage, showjumping and cross-country. Two people achieved the required standard in the HSI Level 2 Coach course in 2015: Amy Fitzgerald and Mary Ellen Rice.

In November 2015, the first multidiscipline HSI Level 3 Coach course began. Twenty-five coaches attended the initial course days, which took place at Cavan Equestrian Centre and at the National Sports Campus, Abbotstown.

The HSI Level 3 Coach course aims to provide coaches with the capacities to train performance riders to compete at the highest level in regional and national competitions (up to 1.45m showjumping, Prix St George dressage and 3-star eventing). The HSI Level 3 Coach course is discipline-specific so each candidate specialises in their chosen field and there are some core elements which will be similar in all three fields. However, some coaches did choose to specialise in more than one discipline. Six dressage candidates, 14 showjumping candidates and eight eventing candidates attended each day, which was affiliated by top-class equestrian coaches, tutors and professionals. Candidates travelled from all over Ireland, as well as from Istanbul and America, to take part. Heike Holstein delivered the dressage practical sessions, Comdt John Ledingham and Denis Flannelly delivered the showjumping sessions and Yogi Breisner delivered the eventing sessions. Day two at the National Sports Campus was delivered by Liam Moggan of Coaching Ireland, who delivered a very insightful session on the role of the coach, improving coach communication skills, coaching delivery styles and refining the structure of the coaching session. Day three began with Fédération Equestre Internationale (FEI) veterinary delegate, John Killingbeck, discussing veterinary care of the competition horse. He was joined by rider physiotherapist, Andy Thomas, to discuss physical fitness and asymmetry of the rider. This made for a very interactive day with practical and theory sessions throughout, concentrating on both horse and rider.

The HSI Level 3 Coach course is a nine-day course in total and will continue throughout 2016, with the first batch of final assessments expected to take place before the end of next year.

### **Anti-Doping Programme**

In 2015, the fourth year of the National Anti-Doping Programme, a total of 80 horses were sampled with no positive results. Four affiliate organisations participated in the programme. Introduced by HSI for horses competing in equestrian competitions in Ireland, the programme is run in conjunction with HSI's affiliates and was devised by the HSI Rules Committee. Results from the 2015 programme can be seen in the table below.

#### FEI Clean Sport

The Fédération Equestre Internationale (FEI) carries out testing on horses at international competitions. Ireland is placed in Group I and II for the FEI Equine Anti-Doping and Controlled Medication Programme (EADCMP). In 2015, a total of 5,096 horses were tested worldwide and 3,594 of those were tested within Group I and II. A total of 122 of those tested from Group I and II were horses and ponies ridden by Irish riders in international competition. All of the samples taken were found to be clean when tested in the FEI laboratories. No horse ridden by an Irish rider has tested positive in a FEI competition since 2008.

#### Garda Vetting/AccessNI

HSI is registered with the National Vetting Bureau (NVB) to conduct vetting for members in the Republic of Ireland. In 2014, HSI signed up to a Service Level Agreement with the Northern Ireland Sports Forum (NISF), a registered umbrella body with AccessNI, to conduct vetting for members in Northern Ireland. Vetting is carried out by the GCVU and NISF in respect of individuals who are applicants for positions, whether full-time, part-time, voluntary or student placements, within organisations by virtue of which they may have unsupervised access to children or vulnerable adults. HSI is committed to ensuring that the safest possible environment for young people exists and one of the ways HSI ensures this is through the vetting system provided for HSI affiliates.

### **New Initiatives**

#### Strategic Plan Launched

In March, the then Minister for Agriculture, Food and the Marine, Simon Coveney, launched Reaching New Heights: Report of the Irish Sport Horse Industry Strategy Committee, which contains a wide range of recommendations for the development of the sport horse industry over the next 10 years.

Speaking at the launch at the Irish Army School of Equitation in Dublin, Minister Coveney said; "I commend Horse Sport Ireland (HSI), Teagasc and the Royal Dublin Society, who have combined their expertise to produce this comprehensive report which involved a detailed consultation process with stakeholders. I was delighted to have been able to attend a number of the regional meetings that were organised as part of that process".

The report contains 35 key recommendations over a broad range of issues, including improving the quality of horses

through more focused breeding, developing the education and training structure for the transfer of knowledge to breeders, improving the marketing and sales capacity across the industry, increasing participation in the sector, progressing the health and welfare of horses and deepening the institutional capacity to deliver on the goals of the strategy. Minister Coveney added: "I have been conscious of the absence of a coherent vision and plan for the sport horse sector to enable it to grow and develop and reach its full potential. We have all the natural advantages for horse breeding and production in this country, a natural affinity for the horse, an abundance of horsemanship and world class riders."

Acknowledging that there has been significant investment in equestrian infrastructure including a wide range of equestrian educational and training facilities he said: "We need to take full advantage of the infrastructure and expertise that has been built. I believe that the report that is being launched today provides the framework to harness our resources in order to achieve our goals".

The former Minister emphasised: "It is not always appreciated that the sport horse sector contributes over €700m per annum to the economy, and reaches into communities the length and breadth of the country." He underlined the Government's commitment to the development of the sport horse industry, saying: "The extra funding that was made available to Horse Sport Ireland from budget 2015 will facilitate plans to enhance marketing, to increase prizemoney across a range of competitions and to stimulate some innovative events."

Concluding, Minister Coveney said that the strategic report provides a roadmap to inject greater confidence and professionalism into the industry and will be used as a vehicle to promote and inform policy with particular emphasis on job creation and sustainable enterprise development and the facilitation of export-led growth.

#### HSI Sport Horse Foal Championship 2015

HSI introduced a Sport Horse Foal Championship in 2015 with a very generous prize fund of €30,000. The aim of the Championship was to identify, evaluate and reward breeders who have bred a foal that has the potential to be competitive at the highest International level in the disciplines of showjumping or eventing.

Six regional qualifiers were held throughout the country with separate sections for potential showjumping foals and potential eventing foals. Four foals were selected from each qualifier for the Final; the best showjumping type colt and filly, and the best eventing type colt and filly.

A total of 158 foals competed in the qualifiers, out of which 24 were selected to compete the final of the inaugural HSI Sport Horse Foal Championship, which took place at Millstreet International Horse Show on the 16th August, 2015.

#### **HSI Mare Championships**

HSI also introduced a new HSI Mare Showjumping Championship and Mare Eventing Championship for five- and six-year-old mares in 2015. The two separate Championships had a prize fund of €15,000 and each aimed to identify, evaluate and reward owners of mares that are capable of performing at the highest level in showjumping or eventing and are suitable for producing progeny that would be competitive in that discipline.

The inaugural HSI Mare Show Jumping Championship took place at Wexford Equestrian Centre on the 1st November 2015, where Cruicerath Flexianna (ISH), bred by Gerard Campbell, Kildare, and owned by USA Young Jumpers LLC, was ridden to victory by Eddie Moloney.

The inaugural HSI Eventing Mare Championship was held on the 13th September, 2015 at Lisgarvan House, Co. Carlow. Graf Maypole (ISH), ridden by Lindsay Graham and owned by Gilbert Graham took first place. This 2009 mare is by Metropole (KWPN), out of Graf Phantom (ISH), by Porsch (BWP) and was bred by Brian Livingstone, Co. Down.

#### Jumping in the City

In 2015, a new showjumping event called Jumping in the City was unveiled. Launched at Shelbourne Park Greyhound Stadium by Simon Coveney TD, the then Minister for Agriculture, Food and the Marine, Jumping in the City took place in greyhound stadia in Limerick, Cork and Dublin on Friday nights during the month of June. It hoped to attract not just showjumping fans, but also people looking for an alternative experience on their Friday night out. Run by HSI, in conjunction with the Irish Greyhound Board and Showjumping Ireland, Jumping in the City saw three different classes of competition each night — an amateur series for grassroots riders, a Grand Prix for Ireland's top riders and crowd favourite, the puissance, where riders try to jump a huge red wall as it is built progressively higher. The new initiative was met with enthusiasm from the industry, with entries being well oversubscribed. HSI was delighted to engage The Underwriting Exchange as Grand Prix sponsors, Devenish as sponsors for the puissance and Westwood Ifor Williams as sponsors of the amateur series. Jumping in the City was in support of Special Olympics Ireland equestrian athletes travelling to represent Ireland at the World Summer

The overall series was a resounding success, attracting 1,500 attendees to Limerick, 2,000 to Cork and 3,500 to Shelbourne Park. Jumping in the City attracted top riders based both in Ireland and abroad, with top Irish internationals Bertram Allen, Billy Twomey, Cian O'Connor and Dermott Lennon lining out to compete.

#### **Awards**

In November 2015, Horse Sport Ireland (HSI) won the Best Innovation in Sport award at the Sport Industry Awards 2015, organised by the Federation of Irish Sport. One of three shortlisted, the Jumping in the City initiative that saw top-level showjumping take place in Irish greyhound stadia during the summer, took the winner's trophy at the ceremony held in the Smock Alley Theatre, Dublin.

The award, sponsored by *The Sunday Business Post*, was given to Jumping in the City under various criteria, including: 'seizing an opportunity to create a new market or industry'; creating an 'effective communication strategy around the innovation'; and producing 'an immediate and likely longer term impact on sport'.

In December 2015, the Irish showjumping team won an Outstanding Team Achievement award at the Irish Youth Foundation Excellence in Sport Awards. The annual awards recognise outstanding contributors to Irish sport. The Irish showjumping team were chosen as award recipients on the back of their victory in the Aga Khan Nations Cup at the RDS in August.

The Aga Khan team of Bertram Allen, Greg Broderick, Cian O'Connor and Darragh Kenny, and team manager, Robert Splaine, joined a galaxy of sporting stars on the night. The awards were hosted by three-time Major golf champion, Padraig Harrington, while jockey AP McCoy received the Outstanding Lifetime Achievement award. Ten awards were presented on the evening, with funds raised going to the Irish Youth Foundation.

#### Investec Sponsorship

In 2015, Investec and HSI announced a sponsorship partnership that confirmed Investec as the first-ever corporate sponsor for the Irish showjumping team. The partnership saw Investec sponsoring Team Ireland's involvement in Dublin Horse Show and the FEI European Championship at Aachen, Germany – a key stage for HSI as Ireland's showjumpers focused their individual and collective efforts on qualifying for the Rio Olympics in 2016. Investec in Ireland is a leading specialist bank and wealth

investment manager, based in Dublin. It is part of a leading international specialist-banking group, with headquarters in Johannesburg, South Africa. Investec Ireland has undertaken a number of high-profile sponsorships and is the current sponsor of Monaghan GAA. It has also developed enduring relationships with leading sports figures, such as Paul McGinley and Jonathan Sexton. Internationally, Investec has a sponsorship portfolio encompassing horseracing, cricket, golf, hockey and cultural events.

Speaking at the launch of the sponsorship, Michael Cullen, Chief Executive of Investec Ireland said: "Investec is really pleased to partner with HSI. Ireland is an exemplar in the equestrian world – renowned for breeding world-class horses and developing showjumping talent to compete with the very best at international level. Its commitment to excellence reflects on our own focus in Investec, on being the very best at what we do. This latest sponsorship builds on many high profile and enduring engagements Investec has both in Ireland and internationally with leading teams and sporting individual sporting figures in golf, rugby, hockey and horse racing." The Investec Irish Showjumping Team went on to win the 2015 Dublin Nations Cup and claimed the prestigious Aga Khan trophy.

#### Knowledge Transfer Programme

In October 2015, HSI announced its intention to establish five equine discussion groups under the new Department of Agriculture, Food and the Marine's (DAFM) Knowledge Transfer Programme. HSI staff member, Michael Doherty, has been approved as one of the facilitators for the scheme by DAFM.

A suite of knowledge transfer measures are included in the new Rural Development Programme 2014-2020, which includes support for knowledge transfer groups across the beef, sheep, dairy, poultry, tillage and equine sectors. The measure is co-funded by the European Agricultural Fund for Rural Development (EAFRD) with total funding of €100 million available for the measure under the Rural Development Programme. This will provide for 27,000 farmers participating for three years in knowledge transfer groups across the dairy, beef, equine, sheep, tillage and poultry sectors. The programme will be administered by the DAFM and delivered by a network of DAFM-approved facilitators.

The scheme design has been guided by experiences from previous Dairy Advisory Schemes and Beef and Sheep Discussion Groups and following extensive consultation with a wide range of stakeholders. The scheme builds significantly on the discussion group model and is designed in such a way as to ensure the farmer and advisor engage in one-on-one discussion on key aspects of a farmers' business, such as profitability, environmental sustainability, breeding and herd health.

Based on the level of interest from breeders received by HSI, Michael Cullen will be facilitating groups in Tipperary, Galway, Sligo, Kildare and a there are plans for a joint Laois/Offaly group. Each group has received the maximum of 18 applications. On successful completion of the programme, each participating breeder will receive an annual payment of €750 per annum for three years.




#### ISC/HSI International Hosting Financial Supports 2015

# **Directors' report**For the Year Ended 31 December 2015

The directors present their annual report and the audited financial statements for the year ended 31 December 2015.

#### Principal activities

The principal activity of Horse Sport Ireland is to promote the sport horse sector in Ireland and to co-ordinate the breeding, sport and leisure aspects of the industry. #### Notes to the financial statements

For the Year Ended 31 December 2015

#### 1. Accounting policies

#### 1.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland and Irish statute comprising of the Companies Act 2014. Information on the impact of first-time adoption of FRS 102 is given in note 16.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgment in applying the Company's accounting policies (see note 2).

The following principal accounting policies have been applied:

#### 1.2 Revenue

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured. Revenue is measured as the fair value of the consideration received or receivable, excluding discounts, rebates, value added tax and other sales taxes.

The following criteria must also be met before revenue is recognised:

#### Sale of goods

Revenue from the sale of goods is recognised when all of the following conditions are satisfied:

- · the Company has transferred the significant risks and rewards of ownership to the buyer;
- the Company retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- · the amount of revenue can be measured reliably;
- · it is probable that the Company will receive the consideration due under the transaction;
- $\cdot$  the costs incurred or to be incurred in respect of the transaction can be measured reliably.

#### 1.3 Tangible fixed assets

Tangible fixed assets under the cost model are stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

The Company adds to the carrying amount of an item of fixed assets the cost of replacing part of such an item when that cost is incurred, if the replacement part is expected to provide incremental future benefits to the Company. The carrying amount of the replaced part is derecognised. Repairs and maintenance are charged to profit or loss during the period in which they are incurred.

Depreciation is charged so as to allocate the cost of assets less their residual value over their estimated useful lives, using the straight-line method.

Depreciation is provided on the following basis:

Leasehold property- 25% straight lineFixtures and fittings- 25% & 20% straight lineEquipment- 25% & 20% straight line

The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date. Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised within 'other operating income' in the Statement of comprehensive income.

#### 1.4 Valuation of investments

Investments in subsidiaries are measured at cost less accumulated impairment. Where merger relief is applicable, the cost of the investment in a subsidiary undertaking is measured at the nominal value of the shares issued together with the fair value of any additional consideration paid.

(A company limited by guarantee)

Investments in unlisted Company shares, whose market value can be reliably determined, are remeasured to market value at each balance sheet date. Gains and losses on remeasurement are recognised in the Income statement for the period. Where market value cannot be reliably determined, such investments are stated at historic cost less impairment.

Investments in listed company shares are remeasured to market value at each Statement of financial position date. Gains and losses on remeasurement are recognised in profit or loss for the period.

#### 1.5 Stocks

Stocks are stated at the lower of cost and net realisable value, being the estimated selling price less costs to complete and sell. Cost is based on the cost of purchase on a first in, first outbasis. Work in progress and finished goods include labour and attributable overheads.

At each reporting date, stocks are assessed for impairment. If stock is impaired, the carrying amount is reduced to its selling price less costs to complete and sell. The impairment loss is recognised immediately in profit or loss.

#### 1.6 Debtors

Short term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

#### 1.7 Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.

In the Statement of cash flows, cash and cash equivalents are shown net of bank overdrafts.

#### 1.8 Financial instruments

The Company only enters into basic financial instruments transactions that result in the recognition of financial assets and liabilities like trade and other accounts receivable and payable, loans from banks and other third parties, loans to related parties and investments in non-puttable ordinary shares.

Debt instruments (other than those wholly repayable or receivable within one year), including loans and other accounts receivable and payable, are initially measured at present value of the future cash flows and subsequently at amortised cost using the effective interest method. Debt instruments that are payable or receivable within one year, typically trade payables or receivables, are measured, initially and subsequently, at the undiscounted amount of the cash or other consideration, expected to be paid or received. However, if the arrangements of a short-term instrument constitute a financing transaction, like the payment of a trade debt deferred beyond normal business terms or financed at a rate of interest that is not a market rate or in case of an out-right short-term loan not at market rate, the financial asset or liability is measured, initially, at the present value of the future cash flow discounted at a market rate of interest for a similar debt instrument and subsequently at amortised cost.

Investments in non-convertible preference shares and in non-puttable ordinary and preference shares are measured:

- at fair value with changes recognised in the Income statement if the shares are publicly traded or their fair value can otherwise be measured reliably;
- ii) at cost less impairment for all other investments.

Financial assets that are measured at cost and amortised cost are assessed at the end of each reporting period for objective evidence of impairment. If objective evidence of impairment is found, an impairment loss is recognised in the Income statement.

For financial assets measured at amortised cost, the impairment loss is measured as the difference between an asset's carrying amount and the present value of estimated cash flows discounted at the asset's original effective interest rate. If a financial asset has a variable interest rate, the discount rate for measuring any impairment loss is the current effective interest rate determined under the contract.

For financial assets measured at cost less impairment, the impairment loss is measured as the difference between an asset's carrying amount and best estimate, which is an approximation of the amount that the Company would receive for the asset if it were to be sold at the reporting date.

#### 1.8 Financial instruments (continued)

Financial assets and liabilities are offset and the net amount reported in the Statement of financial position when there is an enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

Derivatives, including interest rate swaps and forward foreign exchange contracts, are not basic financial instruments. Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently re-measured at their fair value. Changes in the fair value of derivatives are recognised in profit or loss in finance costs or income as appropriate. The company does not currently apply hedge accounting for interest rate and foreign exchange derivatives.

#### 1.9 Creditors

Short term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.

#### 1.10 Foreign currency translation

#### Functional and presentation currency

The company's functional and presentational currency is Euros.

#### Transactions and balances

Foreign currency transactions are translated into the functional currency using the spot exchange rates at the dates of the transactions.

At each period end foreign currency monetary items are translated using the closing rate. Non-monetary items measured at historical cost are translated using the exchange rate at the date of the transaction and non-monetary items measured at fair value are measured using the exchange rate when fair value was determined.

Foreign exchange gains and losses resulting from the settlement of transactions and from the translation at period-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the Income statement except when deferred in other comprehensive income as qualifying cash flow hedges.

Foreign exchange gains and losses that relate to borrowings and cash and cash equivalents are presented in the Income statement within 'finance income or costs'. All other foreign exchange gains and losses are presented in the Income statement within 'other operating income'.

#### 1.11 Pensions

The company operates a defined contribution pension scheme and the assets of the scheme are held separately from those of the company in an independently administered fund. The pension cost charge represents contributions payable by the company to the fund.

#### 1.12 Taxation

Tax is recognised in the Income statement, except that a change attributable to an item of income and expense recognised as other comprehensive income or to an item recognised directly in equity is also recognised in other comprehensive income or directly in equity respectively.

The current income tax charge is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the reporting date in the countries where the Company operates and generates income.

#### 2. Judgments in applying accounting policies and key sources of estimation uncertainty

When preparing the financial statements, management makes a number of judgments, estimates and assumptions about the recognition and measurement of assets, liabilities, income and expenses.

#### Useful lives of depreciable assets

Management reviews its estimate of the useful lives of depreciable assets at each reporting date, based on the expected utility of the assets. Uncertainties in these estimates relate to technical and physical obsolescence that may change the utility of certain assets.

#### Accrued amounts

Management have to use their best estimate for some costs in relation to the financial year where bills have not yet been received at year end date in order to give a true and fair view of the financial statements.






